IV. Discussion and Action Item:

- 1. Review and Approve Additions to the Eligible Training Provider List (ETPL):
 - a) Medical Coding and Billing Occupational Certificate
 - b) Detention Officer Training Academy
 - c) Basic Public Safety Dispatcher

Nidia Herrera stated the trainings must be approved by the Board and State. Approved trainings will be added to the ETPL to allow providers to send interested individuals to the training programs.

Elena Felix provided an overview for the three listed training programs,

- Informed the committee the training programs will be offered through Arizona Western College
- All three programs are within the training costs limit of \$5,500.00

Medical Coding and Billing Occupational Certificate

- Prepare students to take the Certified Professional Coder from the American Academy of Professional Coders
- 28 credit program
- About three semesters long
- Online program
- Total In-State cost is \$4,152.83
- Projections show a total of 49 openings for Yuma County for 2020-2022

Detention Officer Training Academy

- Prepare students for entry level detention officer positions
- 16 credit program
- Not eligible for Financial Aid, Fee based only
- Cost is \$4,075.00 for Yuma residents
- Academy was proposed by the Yuma County Sheriff's Office
- \$18.87 per hour
- Yuma County Sheriffs Office, La Paz, Coconino and Mohave are committed to hiring graduates and are also eligible to work with 11 other County Sheriff Offices within the State of Arizona
- Projections show a total of 72 openings for Yuma County for 2020-2022

Basic Public Safety Dispatcher

- Prepare students for basic roles and duties of a public safety dispatcher within the law enforcement agency
- Student will earn an educational certificate
- 12 credit program
- Cost is \$1,080.00
- Projections show a total of 37 openings for Yuma County
