2. Approval of the August 8, 2022 Meeting Minutes

Motion made by Susan Aguilar to approve the minutes from the August 8th, 2022 Goal Group 3 meeting. Richard Wilkie Seconded. Motion passed unanimously.

3. **Review of Pinal County Workforce Development Board Strategic Plan - Goal #3**

Discussed the development of a Data Dashboard by workforce board staff. Metrics have yet to be identified. Tim Tucker offered to help with data from the Virtual Office data being collected by the DES Workforce Development Administration.

4. **“One-Stop Operator Update on the Pinal Way 22**

Jezreel provided an update on the implementation of the Pinal Way 22.

TRANSFRVR: A Train the Trainer session was held on August 25, 2022 for ARIZONA@WORK Pinal County staff to learn how to use the TRANFRVR headsets. 12 out of 25 training slots were filled. Initial plans are to host an “open house” – at the job center in Casa Grande - promote the availability of the headsets as well as provide information on ARIZONA@WORK Pinal County services. The “open house’ approach can be used at other locations in the county. Target: October 1.

Arizona Career Readiness Credential (ACRC): Jezreel continues to plan for the establishment of the ARIZONA@WORK Pinal County Career and Business Center in Casa Grande as an ACRC testing site. This will require the identification of staff to be certified as testing proctors.

Virtual Services: Work continues in the development of a robust virtual service offering model.
